BE IT RESOLVED, by the St. Tammany Fire Protection District No. 3 of the Parish of St. Tammany, Louisiana, in a public meeting held on July 31, 2024, which meeting was conducted in accordance with the Open Meeting Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the taxing district voted to increase the millage rate(s), but not in excess of the prior year's maximum rate(s), on all taxable property shown on the official assessment roll for the year 2024, and when collected, the revenues from said taxes shall be used only for the specific purposed for which said taxes have been levied. Said millage rate(s) are:
